

**SOLAR HARNESS DOOR PRIZE SPONSORSHIP  
PERTH HOME SHOW 2018**

**TERMS AND CONDITIONS**

1. Information on how to enter and the prizes forms part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The Promotional Period commences on **23 JULY 2018 at 9.00am (AEDST) and closes on Sunday 12 AUGUST 2018 at 4.59pm (AEDST)**
3. Entry is open to residents of Australia only. Employees (and their immediate families) of the Promoter(s) are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1<sup>st</sup> cousin.
4. Any entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter(s) to enter into a further agreement as evidence of consent to the minor entering this promotion.
5. To enter, individuals must complete the following steps during the Promotional Period:
  - a. Visit the Perth Home Show at the Perth Convention and Exhibition Centre, between **10 August and 12 August 2018**;
  - b. Register their ticket so that it's associated with their contact details. This can be done online or onsite at the event;
  - c. Take their ticket to the **SOLAR HARNESS Stand - location B04** and have a promotional staff member scan their ticket's QR code;
  - d. Agree to be contacted via the contact details used when registering; and
  - e. Accept the competition Terms and Conditions.
6. The Prize is a **fully installed 2.2 kW SOLTARO Solar System valued at \$6,274 and a battery to the system valued at \$6,170**. If the winner of the prize is under the age of 18 years, the prize will be awarded to the winner's nominated parent or guardian on the winner's behalf. A computerised draw will take place at the **SOLAR HARNESS office: 2/5 Sequoia Place, Bibra Lake WA 6163** before **Friday 17 August 2018 at 5pm (AEDST)**. The first valid entry draw will win the prize indicated in clause six (6) above. For the removal of doubt there will only be one (1) winner for each prize in this promotion. The draw conductor may draw additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn.
7. Solar Harness has right to retain the STC value.
8. Prize is for single storey installation in the metro Perth area.
9. Prize valid for single-phase properties only for the battery. Addition of hybrid inverter with battery may change the customers REB's.

Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under similar consumer protection laws in the State and Territories of Australia (Non-Excludable Guarantees). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability for any personal injury or any loss or damage whether direct, indirect, special or consequential arising in any way out of the promotion or use of a Prize.
