

**SOLAR HARNESS DOOR PRIZE SPONSORSHIP  
PERTH HOME SHOW 2019**

**TERMS AND CONDITIONS**

1. Information on how to enter and the prizes forms part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The Promotional Period commences on **9 AUGUST 2019 at 9.00am (AEDST) and closes on Sunday 11 AUGUST 2019 at 7.59pm (AEDST)**
3. Entry is open to residents of Australia only. Employees (and their immediate families) of the Promoter(s) are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1<sup>st</sup> cousin.
4. Any entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter(s) to enter into a further agreement as evidence of consent to the minor entering this promotion.
5. To enter, individuals must complete the following steps during the Promotional Period:
  - a. Visit the Perth HIA Home Show at the Perth Convention and Exhibition Centre, between **9 AUGUST and 11 AUGUST 2019**;
  - b. Register their ticket so that it's associated with their contact details. This can be done online or onsite at the event;
  - c. Take their ticket to the **SOLAR HARNESS Stand - location B04** and have a promotional staff member scan their ticket's QR code;
  - d. Agree to be contacted via the contact details used when registering; and
  - e. Accept the competition Terms and Conditions.
6. The Prize is a quality, fully supplied, installed and commissioned 6.6kW system, with a 5kW inverter, on a home without solar modules. RRP for this system is currently \$7,337.
7. If the winner of the prize is under the age of 18 years, the prize will be awarded to the winner's nominated parent or guardian on the winner's behalf. A computerised draw will take place at the **SOLAR HARNESS office: 2/5 Sequoia Place, Bibra Lake WA 6163** before **Friday 16 August 2019 at 2pm (AEDST)**. The first valid entry draw will win the prize indicated in clause six (6) above. For the removal of doubt there will only be one (1) winner for each prize in this promotion. The draw conductor may draw additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn.
8. Solar Harness has the right to retain the STC value.
9. Usable space will dictate the size of the system if there is not enough usable space for a 6.6KW system. This will be determined solely by Solar Harness and if a smaller system is more suitable this will be used.
10. Prize is for a single storey and single phase installation in the metro Perth area, additional charges will apply to a 3phase and or Double storey home.
11. Only one (1) vote and one (1) entry permitted per person.
12. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.
13. The total prize pool is one (1) prize valued at **\$7,337 total**.
14. The winner will be notified by phone and email on **Friday 16 August 2019**.
15. The Promoter reserves the right, at any time, to verify the validity of entries, registrations and entrants (including an entrant's identity, age and place of residence) and to disqualify any entrant who submits an entry or registration that is not in accordance with these Terms and Conditions or who tampers with the entry/registration process. Errors and omissions may be accepted at the Promoter's

Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under similar consumer protection laws in the State and Territories of Australia (Non-Excludable Guarantees). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability for any personal injury or any loss or damage whether direct, indirect, special or consequential arising in any way out of the promotion or use of a Prize.
